What is the purpose of this update?

Description of this fund

The International Share Fund invests mainly in international equities. Investments may include:


- equities in companies that are listed on a recognised stock exchange, and
- cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

What are the risks of investing?

Risk indicator for the International Share Fund:



^{*}The manager expects that the fund charges for the next scheme year will be different from the fund charges disclosed in this fund update because the manager's basic fee was reduced on 1 July 2019 from 1.10% to 1.00% per year.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about Scheme fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$2,747 (that is 27.47% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total gain after tax of \$2,747 for the year.


